“The supplements we give you and Andy are individualized for your own
unique needs --- and they all work synergistically together. When Andy forgets
the Oxy D+, the Balanced Metabolism and the increase in Vital Reserves we
strive to achieve are compromised severely.”

Doctor, surely you noticed something about those three quotes. - - - - -
There is no mention in any of them about “treating diseases”.

This absence of disease reference ties in perfectly with Nutri-Spec’s recent
FDA encounter. We were slammed pretty severely because in the FDA’s
judgement, too much of what we write implies that Nutri-Spec supplements are
effective in preventing disease. But, really that has never been our intent.

Our position is that the only prevention of disease is in building health ----
and the way to build health is to increase ADAPTIVE CAPACITY ---- and the
way to build ADAPTIVE CAPACITY is to strive for Metabolic Balance + high
Vital Reserves.

Maximizing health, as we like to present it, provides a protective shield
against Immuno Nevro-Endocrine-Stress --- which, by definition, controls

Among those of you who sent emails expressing your shock and regret at
learning of the FDA action against Nutri-Spec, one doctor said it quite
succinctly. He commented that, “The FDA claim against Nutri-Spec is not only

His view is that the FDA is looking in the exact opposite direction of where it

Silly. ----- See the obvious built-in exasperation of failure when following the
lost crowd.

In a sense, the FDA action has clarified who we are --- how we as Nutri-Spec practitioners stand poles apart from the herd.

Nutri-Spec, is stark contrast to the desperate and frustrated seekers of symptom relief, is diametrically opposed to the concept of cure mongering. How many times have you heard us practically beg you --- “Empower your patients, do not treat their diseases.”

“Individualize your Metabolic Therapy for each patient --- regardless of what symptoms or diseases they have.”
